This letter acknowledges receipt of your timely application to renew your Federal firearms license which you filed for under Title 18, USC, Chapter 44, and the Code of Federal Regulations, 27 CFR §478.45.

Bureau of Alcohol, Tobacco. Firearms and Explosives (ATF) Ruling 75-27 allows you to continue operations under your current license until such time as ATF completes processing your application to renew your Federal firearms license.
